#### **Abstract**

Although the film switched from animation to live-action, the essence of Snow White's story was maintained, with certain elements added and removed to suit the contemporary era.

This article will discuss a comparison between two important adaptations of the Snow White fairy tale: Disney's animated movie *Snow White and the Seven Dwarfs (1937)* and the liveaction film *Snow White and the Huntsman (2012)*. - e. Resolution with Snow White living happily with the prince.

## 2. Snow White And The Huntsman (2012).

- a. Expostion Shows Snow White's happy childhood and mother's death in the exposition.
- b. The rising action occurs when the huntsman agrees to help Snow White in exchange for a reward.
- c. The climax features Snow White leading a battle to reclaim her kingdom.
- d. The falling action has Snow White defeating Queen Ravvena.
- e. Resolution with Snow White reclaiming her throne and being crowned queen.

## F. Similarities between the Snow White And The Seven Dwarfs (1937) and Snow White And The Huntsman (2012) movie.

- 1. Both movies feature the magic mirror, symbolizing truth that cannot be concealed.
- 2. Snow White shares a spiritual bond with animals in both films, surrounded by them in her environment.
- 3. Dwarves appear in both movies, with the 2012 film depicting them more strongly due to its action fantasy genre.
- 4. Snow White is awakened by a kiss in both films; however, in the 2012 film, she wakes up from the Huntsman's kiss, not the prince's.

#### **CONCLUSION**

The conclusion of this study is the difference in storyline between the two films adapted from the same fairy tale, but still maintain typical elements such as the magic mirror, the poisoned apple, and true love's kiss. In "Snow White and the Seven Dwarfs" (1937), Snow White is depicted as a gentle, kind, and dependent character. In contrast, in "Snow White and the Huntsman" (2012), Snow White is depicted as a stronger and more independent figure, reflecting the development of the times and a more complex character.
